**Our Purpose**

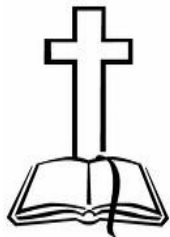

## IVCF Basis of Faith

1. The unity of the Father, Son and Holy Spirit in the Godhead.
2. The Sovereignty of God in creation, revelation, redemption and final judgment.
3. The divine inspiration and the entire trustworthiness of the Holy Scriptures, as originally given, and its supreme authority in all matters of faith and conduct.
4. The universal sinfulness and guilt of all men since the fall, rendering them subject to God's wrath and condemnation.
5. Redemption from guilt, penalty, dominion and pollution of sin, solely through the sacrificial death (as our Representative and Substitute) of the Lord Jesus Christ, the Incarnate Son of God.
6. The bodily resurrection of the Lord Jesus Christ from the dead and His ascension to the right hand of the Father.
7. The presence and power of the Holy Spirit in the work of regeneration.
8. The justification of the sinner by grace of God through Faith alone.
9. The indwelling and work of the Holy Spirit.
10. The one Holy Universal Church which is the body of Christ and to which all true believers belong.
11. The expectation of personal return of the Lord Jesus Christ.



## IVCF POLICY ON CORPORATION MEMBERSHIP

### Regular Membership

**Membership in the corporation shall be by invitation and approval of the Board of Trustees. All members shall be required to subscribe to the IVCF Basis of Faith. Participation in the business meetings of the corporation shall be limited to those members in good standing who reaffirm their agreement with the doctrinal basis of faith and principles, purposes and practices of the fellowship, and who pay the prescribed fees.**

### Qualifications & Duties of a Corporation Member

An IVCF Corporation members agrees to:

1. be one in whose life the fruit of the Holy Spirit is evident;
2. be a member of a local church assembly and participate regularly in Christian fellowship;
3. attend the annual corporation meeting;
4. give financially in proportion to his ability;
5. sign every year the Corporation's Statement of Agreement;
6. participate in various phases of IVCF ministries by praying regularly for the ministry and being active in IVCF work as one of the following: faculty adviser of an IVCF local chapter, GT or ISCF Counselor, reader/user of IVCF Publications, host of staff, participant of graduates ministry, active link of IVCF with his home church and friends;
7. elect the members of the Board of Trustees.

*NOTE: The membership fee for Filipino pastors and missionaries is optional.*
